### Minutes:

1. Opening of the Meeting:

2. Approval of Previous Minutes:

The Secretary presented the minutes of the previous meeting held on 28<sup>th</sup> May 2023. After a thorough review, the minutes were unanimously approved by the members present.

3. Loan Request by Nsubuga Hashim:

The Chairperson introduced the agenda item regarding a loan request made by Mr. Nsubuga Hashim. It was stated that Mr. Nsubuga had submitted an application for a loan of UGX 1,000,000 to support his poultry farming business.

4. Discussion and Decision on the Loan Request:

- a. Business Plan: Mr. Nsubuga presented his business plan, detailing the purpose of the loan and how it would contribute to the growth and development of his growing maize and passion fruit farming venture.
- b. Repayment Plan: Mr. Nsubuga outlined a repayment plan, indicating the proposed schedule and method for repaying the loan. The plan was reviewed and deemed reasonable by the members.
- c. Financial Assessment: The Treasurer provided an overview of the financial standing of the group and confirmed that granting the loan would not pose a significant risk to the group's financial stability.
- d. Loan Terms and Conditions: The members discussed the terms and conditions for granting the loan to Mr. Nsubuga, including the interest rate, repayment period, and any collateral requirements. After careful consideration, it was agreed that the loan would be at an interest of 6% as per the PDM and repayable within a period of 12 months.
- e. Vote on the Loan Request: A formal vote was conducted, and all members present unanimously agreed to approve the loan request of UGX 1,000,000 for Mr. Nsubuga Hashim.
